Terms and Conditions

Cancellation and Refund Policy

All the trips require a non-refundable registration fee of US\$150.00

If you decide to cancel your trip B.A.I. must be notified in writing. If proper written cancellation notice is not received, all amounts paid and any reservations made will be forfeited. You will be assessed a cancellation fee according to the following schedule:

- Full refunds, less registration fee, will be provided 90 days prior to course, trek and expedition date.
- 50% refunds will be provided 60 89 days prior to course/trek and/or expeditions date
- No refunds will be provided 59 days prior to course, trek and/or expedition date. For trips exceeding US \$8,000.00 specialized refund policies may apply.
- All balances are due 90 days prior to departure date unless otherwise specified.
- Participants whose balance are not received by the 90 day deadline as stated above, risk forfeiture of their place on the expedition
- If you wish to transfer from one trip to another, you must notify us in writing and this will take effect upon receipt by us. If we are notified more than 60 days prior to departure, your deposit will be transferred less an administration fee of US \$150.00
- Deposits must be applied to departing not later than one year from time of transfer

Trip Cancellation Insurance

We highly recommend trip cancellation insurance for all expeditions. Due to the nature of government and operators permits, B.A.I. must adhere to a strict refund policy. Specific brochure cancellation and refund policies may supercede those enumerated above.

B.A.I. will take every care with client's baggage and property, but is not liable for loss, damage or delayed delivery.

B.A.I. acts as an agent for the transport, accommodation and services of the companies supplying this trip.

B.A.I. may not be held liable for nonperformance of any such supplier. If the participant is not able or willing to assume the above-mentioned risks, he/she should purchase trip insurance.

Participant Responsibility

Trip participants are responsible for their own well being. This includes good health and strong physical condition. Participants joining a trek or mountaineering expedition may be required to obtain a physician's release prior to departure. Expedition members are responsible for: knowing all pre-departure information, preparing proper equipment and clothing, conforming to basic standards of personal hygiene (to minimize the risk for travellers diseases) and acting in a considerate manner toward all group members and with respect for each country's customs.

Air Carrier Responsibility

The air carrier will not be held responsible for any act, omission or event while the passenger is not on board the designate aircraft or terminal conveyance.

Passenger/Airline contracts stand in effect while the passenger is on board each particular aircraft.
